#### 083(2016-17) Apologies for Absence

Apologies for absence were received from Cllr T Williams and the reason accepted.

# 084(2016-17) Declaration of Interests and Dispensations

#### 085(2016-17) Minutes of the Last Meeting

Resolved: that the minutes of the meeting held on 8 November 2016 be agreed as a true record.

# 086(2016-17) Public Participation (Including Police Report)

Councillors **resolved** to adjourn the meeting to allow members of the public to bring matters relating to the agenda to the attention of the council.

Councillors noted the police reports for the months of October (which was not received in time for the November meeting) and November. Councillors noted that two men were seen to be behaving in a suspicious manner near the building site at the top of Brick House Lane and it had been reported to the site manager.

On the conclusion of public participation councillors **resolved** to reconvene the meeting.

# **087(2016-17)** Stalmine Gala – Request to Use Playing Field and Request for a Donation Councillors considered a request from the Gala Committee to use the playing field again for next year's event on 20 May 2017. Councillors **resolved** to agree to the request on the condition that all litter is removed, that any damage to the field is repaired and that the Committee does not levy a charge for entry but may ask those attending for a donation. The Council also **resolved** that the Gala Committee be required to complete and sign a form indemnifying the Council against any claims.

Councillors also considered a request for a donation towards the costs of putting on the Gala and **resolved** to provide a grant of £100.

#### 088(2016-17) Draft Budget for 2017/18

Councillors noted the successful Awards for All grant application in the sum of £9,800 for play facilities for older children. Councillors considered the draft budget for next year and **resolved** to consider the final budget at the January meeting.

It was agreed that the parish council objects to this proposal on the grounds that there are no services to the field, access is from a single track lane, there are a very small number of stables and horses have been kept at this location for many years without the need for on-site accommodation. Councillors also guestioned what would happen at the end of the three year period.

#### 091(2016-17) Reports from Outside Bodies (for information)

Cllr Jackson reported that she had not been able to attend the recent meeting of the Wyre Flood Forum but had sent a report on flooding issues in the parish.

# 092(2016-17) Clerk's Report (for information)

Councillors noted the Clerk's report in respect of:

#### Playing Field Hedge

Wyre Juniors has confirmed that plans are in place for the fence and the hedge to be replaced although they have had a problem finding hedging to match.

#### Play Equipment Grant Funding

LCC's Parish Champion, County Councillor Dereli, has agreed a grant of £300 towards the play equipment and this can be used as match funding for the application to the Walney Community Fund. Other grant applications have been made to Awards for All and to Persimmon.

#### Parish Wood

A tree surgeon qualified to carry out aerial work has now taken down the tree leaning over a resident's property and cut back two neighbouring trees both to gain access to the tree in question and to prevent problems in future. The resident has agreed to fund 50% of the cost.

#### Water on Staynall Lane

There have been a number of complaint about water running down Staynall Lane which freezes in cold conditions. United Utilities have checked and there is no burst water pipe so the problem has been reported to Lancashire Highways with a request that all the gullies be cleared.

#### Construction of New Veterinary Clinic

Residents will be aware that work has begun to prepare the site for the construction of the new veterinary clinic on the corner of Brickhouse Lane and Carr Lane. In response to a number of complaints of blocked sight lines from parking on the verge, a commitment was given that any vehicles would be parked further away from the new entrance until they could be parked on site. The contractors have moved the parish boundary sign and the flower box that sat underneath it and have it in safe keeping until such time as they can be reinstated.

#### Lancashire Fire and Rescue Service – Draft Integrated Risk Management Plan

Lancashire Fire and Rescue Service is consulting on the draft plan which highlights Lancashire's risk; explains how they will assess, manage and reduce fire and rescue related risk; sets out their priorities and values; sets out their ambitions against each priority and states how they aim to deliver these and illustrates how they will measure and assure performance.
