# Minutes of the Meeting of the Parish Council held on Monday 20 January 2014 at 7pm at the Village Hall, Stalmine

Present: Cllrs D Anderson (Chairman), S Carrington J Jackson, K Jenkinson and A Wallace

**In Attendance**: Jan Finch, Clerk to the Council, PCSO Terry Molloy (Item 4) and one member of the public.

#### 150(2013-14) Apologies for Absence

None.

#### 151(2013-14) Declaration of Interests and Dispensations

The Clerk reminded councillors that they all had a pecuniary interest in item 5 (draft budget for 2014/15) as they were all council tax payers but that they had all been granted a dispensation by the Council which allowed them to discuss and vote on the precept.

# 152(2013-14) Minutes of the Last Meeting

**Resolved**: that the minutes of the meeting held on 16 December 2013 and the extraordinary meeting on 6 January 2014 be agreed as a true record.

#### 153(2013-14) Public Participation (Including Police Report)

Councillors **resolved** to adjourn the meeting to allow members of the public to bring matters relating to the agenda to the attention of the council. PCSO Molloy provided an update on the small amount of crime and anti-social behaviour in the parish. He encouraged residents to report non-emergency matters using the 101 number.

A member of the public expressed his disappointment at the responses from United Utilities at the recent meeting and councillors agreed to ask the Clerk to write to Ben Wallace MP to seek his support on moving the Smithy Lane/Porters Row project up the agenda.

On the conclusion of public participation councillors **resolved** to reconvene the meeting.

# 154(2013-14) Draft Budget for 2014/15

Councillors considered the draft budget options. In the light of Wyre Council's decision to withdraw the rural grant and not to passport local council tax support monies, worth in the region of £3600 to the Town Parish Council, councillors **resolved** that the precept for 2014/15 be set at £16,131.

#### 155(2013-14) Change of Bank Account

Councillors noted that there had been no activity on the Playing Field Account for some time and **resolved** to ask RBS to rename the account to "General Reserve Account".

#### 156(2013-14) Community Engagement Strategy

Councillors noted that the community engagement strategy should be reviewed annually and **resolved** to approve the revised draft, incorporating changes to methods of communication and bringing the public participation at meetings section into line with the Council's Standing Orders.

#### 157(2013-14) Lancashire & Merseyside County Training Partnership

Councillors noted that the County Training Partnership will run a Finance workshop on 13 February 2014 from 7 to 9pm at a cost of £25 and a Chairmanship Workshop on 6 March.

#### 158(2013-14) Roadside Working Training

Councillors **resolved** to arrange roadside working training for the Lengthsman to ensure road safety.

# 159(2013-14) Corner of New Road and Highgate Lane

Cllr Anderson proposed that shrubs be planted on the triangle in place of the raised bed which had to be removed. Councillors **resolved** to plant it with low growing shrubs in line with the requirements of LCC.

# 160(2013-14) Winter Newsletter

Councillors **resolved** that the winter newsletter include articles on the help and support available through Help Direct, a request to landowners to clear dykes, the 101 non-emergency number, the additional litter bins in the village and how to report nuisance drivers.

#### 161(2013-14) Closure of Wood View and Carr End Lane

Councillors noted that the full length of both roads from the junction with Grange Lane to the junction with the A588 Carr Lane will be closed between 7am and 5pm from 17 February to 23 May to allow new high voltage cables to be installed. The diversion will be via Smithy Lane/Mill Lane/Stricklands Lane. Access will be restricted to pedestrians but access for residents will be provided.

#### 162(2013-14) Parish Action Plan

Councillors considered the draft action plan that had been developed using the results of the recent parish survey and other issues already known to the parish council. Councillors noted that the Clerk had sent the issues relating to Lancashire County Council, Lancashire Constabulary and Wyre Council to the respective organisations for information and action.

In respect of the flooding issues contained in the action plan councillors **resolved** to facilitate the setting up of a Stalmine Flood Action Group in conjunction with the Environment Agency and other key partners.

Councillors **resolved** to accept the action plan which would be updated on a quarterly basis and noted that the action plan would be uploaded to the website and progress publicised using the regular Over Wyre Focus article and the blog.
