011(2017-18) Insurance 2017/18

Councillors considered a quotation from Zurich and, through Came and Company, three quotations from Inspire/AXA, Hiscox and Ecclesiastical. Councillors noted that all insurers provided the cover required by the parish council and all were well experienced providers with solid reputations. Councillors therefore **resolved** to accept the cheapest quotation, that being from Inspire/AXA, and to enter into a 3 year agreement which guarantees the price.

016(2017-18) Reports from Outside Bodies (for information)

In Cllr Williams' absence, the Clerk reported that the recent meeting of the Wyre Area Committee had received a presentation from Neil Stevens, LCC Highways Development Control, on what planners can and cannot take into account when considering the highways issues in a planning application.

017(2017-18) Clerk's Report (for information)

Councillors noted the Clerk's report in respect of:

Seven Stars

Wyre Council has confirmed that the Seven Stars has been registered as an Asset of Community Value. It is not known at this stage whether the owner, Punch Partnerships Ltd, will request a review of the decision. No further information has been received from SSRA.

Classification of the Morecambe Bay and Duddon Estuary Special Protection Area

Following the consultation on the proposals to combine and extend the Morecambe Bay Special Protection Area (SPA) and Duddon Estuary Special Protection Area (SPA) in 2016 the Secretary of State formally classified the site as a Special Protection Area on 7th February 2017 in accordance with the Conservation of Habitats and Species Regulations, 2010. Natural England and relevant agencies are progressing registration of the site.

The new marine SPA combines the individual Morecambe Bay SPA and Duddon Estuary SPA into one site and includes additional maintenance and foraging areas for Sandwich tern and little tern. The Morecambe Bay & Duddon Estuary SPA protects large numbers of breeding and non-breeding seabirds and water birds, retaining all existing features of the previous Morecambe Bay and Duddon Estuary SPAs (with the exception of breeding eider which no longer fall within scope). In addition, the following species are new features of the Morecambe Bay & Duddon Estuary SPA: black-tailed godwit, whooper swan, little egret, Mediterranean gull, lesser black-backed gull and ruff. The additional marine extension area includes important foraging areas for terns and identified by foraging Sandwich terns breeding at Hodbarrow Lagoon.

Drainage Problems on Staynall Lane

After reporting these problems in November last year and no action taken a complaint was made to LCC. The gully wagon has now attended the area on two occasions and it is hoped that the problems have now been solved.

Public Footpaths 11 and 13

Cllr Williams walked Footpaths 11 and 13 recently and reported that Footpath 11 was passable with a short detour onto Footpath 13 but, at the far end of the footpath, the sign was laid in undergrowth. The sign for Footpath 13 on Wardleys Lane is almost hidden in the hedge. The footpath appears to have been diverted as a result of a large building. Both problems have been reported to LCC's public rights of way team who will investigate and attempt to resolve the issues.
