049(2015-16) Apologies for Absence

Apologies for absence were received from Cllr A Wallace and the reason accepted.

050(2015-16) Declaration of Interests and Dispensations

Cllr Jenkinson declared a non-prejudicial interest in Item 6 (Container for Flood Event Equipment) as a member of the Village Hall Committee.

051(2015-16) Minutes of the Last Meeting

Resolved: that the minutes of the meeting held on 11 August 2015 be agreed as a true record.

052(2015-16) Public Participation (Including Police Report)

Councillors **resolved** to adjourn the meeting to allow members of the public to bring matters relating to the agenda to the attention of the council.

The Clerk reported that there should be a full police report next month as a new volunteer had been recruited.

054(2015-16) Container for Flood Event Equipment

Cllr Jenkinson reported that the village hall committee had now decided that there was no room on the site to locate the container. Cllr Jackson reported that she had identified a possible alternative location on Old Tom's Lane and the Clerk had begun enquiries with Wyre Council and LCC. Councillors resolved to discuss the matter again once the outcome of those enquiries was known.

056(2015-16) Planning Applications

15/00758/FULMAJ

Proposal: Erection of 5 holiday units and erection of a building for a hydrotherapy pool, visitors centre and cafe for disabled visitors and carers **Location:** Brick House Farm Cottages, Brick House Lane, Stalmine

It was agreed that the parish council objects to the proposal on the following grounds: the site is located on a narrow country lane with no speed limit and no passing places. Traffic on the lane has increased considerably given recent planning approvals and the number of large commercial vehicles has become much more common. The lane is now dangerous for pedestrians and riders and the

Parish Council feels that the increase in traffic generated by this development would add to what is already a problem. In addition the Parish Council is of the view that the scale of the development is overintensive for the site and out of character with the rural nature of this part of the village.

General Reserve Account

Councillors noted the Clerk's report in respect of:

Pedestrian Crossing

A letter has been received from Ben Wallace MP enclosing a letter from Phil Durnell, Head of Highways at LCC. In his letter Mr Durnell states tht LCC is still in the process of carrying out traffic assessments and investigations which are unlikely to be completed until the end of 2015. Once completed LCC will determine whether a zebra crossing should be put forward in the centre of the village. He also states that any scheme put forward will have to compete to secure the limited funding that LCC has for road safety facilities. LCC will contact Mr Wallace to advise whether officers can support the request.

Playing Field – Dog Control Orders

Wyre Council has installed updated dog control signs on the playing field including the ban on dogs on the marked sport pitch.

Transparency Grant Application

The Government has established a Transparency Fund to enable parish councils to work towards compliance with the Transparency Code for Smaller Authorities and Councils who have undertaken work or bought equipment after 1 April 2015 solely to comply with the Transparency Code are eligible to apply. A grant application for £612 has been submitted.

Casual Vacancy

Following the resignation of Cllr Carrington after the last meeting Wyre Council has notified the Council that the last date for receipt of a request for an election is 27 October 2015.
