95(3) Minutes of the last meeting

Councillors **resolved** to approve as a correct record the minutes of the meeting held on 11 September 2018.

96(4) Public participation

A member of the public expressed concerns in respect of the proposed development of 65 houses off Carr End Lane. These included flooding, the proposed development land being outside the local plan, issues of access on and off already dangerous roads, impact on wildlife and the general overdevelopment of the village.

97(5) Projects for 2019/20

Councillors considered the current budget position and **resolved** for the following items to be added to the first draft budget for 2019/20 to be considered at the November meeting:

- a) Funding for the management of the trees works to ensure the safety of some of the large trees. Part of extra lengthsman's salary to be earmarked for tree surgeon. Top up the tree work reserve for the larger trees £1000.
- b) Making the wood more accessible and environmentally friendly this would be a long-term project done in stages £1000.
- c) Bus Shelter installation costs £650.
