# Minutes of the meeting of the Parish Council held on Tuesday 14 September 2021 at 7.00pm in the Village Hall, Stalmine

# 35(1) Apologies for absence

# 36(2) Declaration of interests and dispensations

# 37(3) Minutes of the last meeting

**Resolved:** to approve as a correct record the minutes of the meeting held on 20 July 2021.

# 38(4) Public participation

Councillors resolved to adjourn the meeting to allow non-councillors to speak.

- A resident asked if more dog waste bins could be provided. It was advised that Wyre provides the bins after completing a three-yearly survey. The issue is having sufficient resources to empty the bins.
- A resident raised a number of issues afecting residents as a result of the glamping site at Bowses Hill. It was explained that the matter was being dealt with by Wyre Borough. Residents were informed that if they are unhappy with the action being taken they can contact the ombudsman.
- Residents raised concerns regarding young girls walking large, sometimes aggressive, unmuzzled dogs from the RSPCA kennels.
- Residents raised concerns regarding surface water contamination that they
  believed was coming from a new housing development. The residents' association
  representative was keen to write to Wyre regarding this. Cllr Morton strongly
  advised him against this until Paul Long's investigations were completed and his
  report becomes available. The council was asked to obtain a copy of the report.

Councillors **resolved** to reconvene the meeting on the conclusion of public participation.

**Proposal**: Hybrid planning application for two 80-bed care homes with landscaping and associated works (full application), and up to 50 dwellings with access (outline application) (resubmission of 20/01175/FULMAJ)

**Proposal:** Change of use of land and erection of stable block to be used for

private equestrian purposes

**Location:** Field to the west of New Road Hambleton Poulton-le-Fylde

Lancashire

**Resolved:** The council was unanimous in raising no objections to the application, however it did wish to make the following comments:

- 1. The planning application site area of three acres doesn't accord with the revised plan of 2.5 acres.
- 2. The ecological site survey should also reference migratory geese and nesting birds for completeness. There is no mention of either.
- 3. The council would like to ask that if permission is given for this application that it be specified in the decision that it is for private use only with no commercial use or livery and that there be no further extensions to the buildings.

# **Planning enforcement**

A Freedom of Information request was submitted to Wyre Council on 29 July requesting information on planning enforcement action within the parish. No response was received within the 20-day time limit for such requests. An explanation for the lack of response or a formal response has been requested. A response is awaited.

#### Camping aires

The possibility of the council using the car park adjacent to the bowling green as a camping aire was discussed with Wyre Council. Wyre was of the opinion that the area is too small for use as both a car park and aire. There are also issues in that this would become a multi-use area as opposed to the aire in Fleetwood, which is a designated camping spot only.

# Footpath signage

Six posts and associated signage have been collected from Lancashire County Council. The first of these will be installed to clarify the route of the Wyre Way and the remainder will be used to replace missing signage. The plantsman will collect further signage once a date can be arranged with LCC.
